The Influence of Emotional Intelligence, Intellectual Intelligence and Spiritual Intelligence on the Member Performance in Mamuju Regency

ABSTRACT

This study was intended to determine the effect of emotional intelligence, intellectual intelligence, and spiritual intelligence on the performance of members of the Regional House of Representatives of Mamuju Regency. This research was conducted at the office of the Regional House of Representatives, Mamuju Regency, West Sulawesi, by taking 30 members of the Regional House of Representatives as the research sample. The results of this study prove that partially proven emotional intelligence, intellectual intelligence, and spiritual intelligence, have a positive and significant effect on the performance of members of the Regional People's Representative Council. This study also proves that simultaneously emotional intelligence, intellectual intelligence, and spiritual intelligence have an effect on the performance of members of the Regional Representatives Council of Mamuju Regency. This study resulted in a coefficient of determination of 61.8% which indicates that this research model can explain that the performance of members of the Regional House of Representatives of Mamuju Regency is influenced by 61.8% of this research variable and 38.2% is influenced by other variables not examined, in this research.

INTRODUCTION

In this era of globalization, the environmental changes experienced in the organizational environment require every human resource to make adjustments, self-adjustment will be a must to answer all future challenges (Braaf et al., 2017; Hesse, 2018). The power that must be possessed by human resources will realize a concrete concept that becomes a tool for making change. One of them is the management of emotional intelligence, intellectual intelligence and spiritual intelligence (Shih & Stanto, 2010).

The ability of emotional intelligence (EQ), intellectual intelligence (IQ) and spiritual intelligence (SQ) is now the basic capital of national development, especially the development of human resources, human resources, therefore the potential of human resources must always be

So that emotional intelligence must be learned and trained from an early age, and the ability to learn emotional intelligence needs to be developed or honed continuously. Intellectual intelligence will be able to work effectively if it is supported in the functioning of emotional intelligence. If emotional intelligence is not functioned properly, then emotional intelligence will become an emotion that is slowly getting out of control, so that it will have a negative impact on these emotions. Like, fights between colleagues, and others.

A person can be said to be successful by having a high IQ or knowledge intelligence, but if it is not accompanied by SQ or spiritual intelligence, his life will not feel calm. An example that we can take in today's era which is currently rampant is the occurrence of corruption everywhere. Maybe it was done because of a lack of faith or not accompanied by a spiritual attitude, or in other words their intentions and norals were very bad.

Assesses that spiritual intelligence is the highest form of intelligence that combines the two previous forms of intelligence, namely intellectual intelligence and emotional

intelligence. Spiritual intelligence is considered the highest intelligence because it is closely related to people's awareness to be able to interpret everything and is a way to can feel happiness.

Based on the description above, the researcher concludes that the problem that underlies this research is that emotional intelligence (EQ) must be improved by carrying out activities by prioritizing emotional intelligence in intellectual intelligence (IQ). and solve problems, as well as on spiritual intelligence, researchers see many people who do not yet have spiritual intelligence (SQ) in their intellectual control to think critically, emotionally in interacting.

METHOD

This study uses an associative research approach (Gallo et al., 2018). Associative research is a research that looks for the relationship or influence between one variable and another. This research was carried out by the Regional House of Representatives Office of Mamuju Regency. The time of this research was carried out in June – July 2021. With a research sample of 30 respondents who were elected DPRD members in the 2019-2024 period and twenty staff of the Mamuju Regency DPRD.

The data analysis technique used multiple linear regression analysis which was preceded by validity and reliability tests on research data. Hypothesis testing was used t test to test partial correlation and f test to determine the relationship simultaneously. The analysis of significance in this study was used through the coefficient of determination test (R square) (Abuella & Chowdhury, 2015; Uyanık & Güler, 2013).

RESULT AND DISCUSSION

Statistical calculations in multiple linear regression analysis used in this study were using the IBM SPSS for Windows version 23 computer program. The results of data processing using the SPSS program were complete, the regression coefficient values of each variable which included the variable (X1) were obtained emotional, variable (X2) intellectual intelligence, and variable (X3) spiritual intelligence, can be explained as follows:

Based on the multiple linear regression equation above, it can be interpreted that:

- The multiple linear regression formulation above obtained a constant value of 16,820 which
 means that if the score consisting of emotional intelligence, intellectual intelligence, and
 spiritual intelligence, with a fixed value, the performance of members of the Mamuju
 DPRD has a value of 16,820.
- 2. The emotional intelligence regress coefficient value is 0.266, it can be interpreted that if emotional intelligence increases by 1 point, the performance of the members of the Mamuju Regency DPRD will experience a performance increase of 0.266, meaning that there is a positive influence on the performance of the Mamuju DPRD members, assuming other independent variables are held constant.
- 3. The value of 0.202 on the intellectual intelligence variable (X2) is positive so it can be said that the higher the intellectual intelligence of the members of the Mamuju Regency DPRD, the higher the performance of the members of the Mamuju Regency DPRD. The regression coefficient is 0.202 by stating that each additional 1 point will increase the intellectual intelligence of members of the DPRD Mamuju Regency by 0.202 units. Thus, assuming other independent variables are considered constant.
- 4. The value of the regression coefficient of spiritual intelligence is 0.144, it can be interpreted that if spiritual intelligence increases by 1 point, the performance of members of the Mamuju Regency DPRD will experience a decrease in performance of 0.144, meaning that other independent variables are considered constant.

means that the emotional intelligence variable has a positive and significant effect on the performance of members of the Mamuju Regency DPRD.

- 2. The influence of intellectual intelligence (X₂) on the performance of DPRD members in Mamuju Regency (Y), based on the 10 le above, the t-count value > t-table (1,148 > 0.680) and a significant value of 0.004 < 0.05, it can 40 concluded that H2 is accepted and H0 rejected means that the intellectual intelligence variable (X2) has a positive or significant effect on the variable performance of members of the DPRD of Mamuju Regency (Y) it can be said that there is a positive and significant influence on the performance of members of the DPRD of Mamuju Regency.
- 3. Influence Intelligence spiritual (X₃) on the performance of legislators Mamuju (Y) based on the table above were obtained value of t count> t-table (3,682> 0.680 And significant value 0.000 <0.05, it can be concluded H3 acceptable and H0 is rejected, which means that the spiritual intelligence variable has a positive and significant effect on the performance of members of the Mamuju Regency DPRD.</p>

Based on the description of the t-test above, it can be seen that the independent/independent variables, namely the emotional intelligence variable, (X1) and the intellectual intelligence variable (X2) and the spiritual intelligence variable (X3) have a positive and significant effect on the dependent variable (Y).) on the performance of members of the DPRD Mamuju Regency.

Simultaneous Testing (F-Test)

The F test serves to test the variables of emotional intelligence, intellectual intelligence, and spiritual intelligence, from the three variables (X) studied that simultaneously affect the variable (Y). The analysis was carried out using the SPSS ver data processing program tool. 25 which can be described in Table 5.15. following:

Discussion

1. Effect of Emotional Intelligence on the performance of DPRD members in Mamuju Regency.

Based on the results of the t-test where the emotional intelligence of members of the Mamuju Regency DPRD has an effect on the performance of the members of the Mamuju Regency DPRD, this is because of the 30 newly elected DPRD members, they can adjust to the work process in the Mamuju Regency DPRD, because they can understand the substance of the task. The main members of the DPRD, and DPRD members have emotional intelligence because they have been cadres in the party about strategies and tactics in politics so that their emotional intelligence can be well controlled.

2. The influence of intellectual intelligence on the performance of DPRD members in Mamuju Regency .

The results of the hypothesis test have found that the independent variable, namely (X^2) has a positive or significant effect on the performance variable of DPRD members in Mamuju Regency, it can be interpreted that there is an influence of intellectual intelligence of DPRD members because DPRD members feel they have knowledge about their main duties and responsibilities. feel that they have knowledge and procedures in meetings and in leading

meetings in court. Intellectual intelligence for DPRD members will make a real contribution to achieving the goals of their legislative function, because with high intellectual intelligence will channel all abilities and skills to receive and resolve community aspirations, without intellectual intelligence DPRD members will not be able to carry out their duties and obligations in accordance with with the demands of the community it represents.

3. The influence of spiritual intelligence on the performance of members of the DPRD of Mamuju Regency 11

In the results of the hypothesis test where the t-test of the results of the study shows that there is a positive influence of spiritual intelligence on the performance of members of the DPRD of Mamuju Regency, the spiritual intelligence of members must be possessed because it is in the public spotlight, where people are often shown on electronic media where DPRD members are at their prayer times, they still gather and even they are still in court without regard to the obligation to fulfill the obligation of prayer, this is a reflection of the effectiveness of the performance of council members lack spiritual who intelligence.

4. Simultaneous influence of emotional intelligence, intellectual intelligence and spiritual intelligence on the performance of members of the DPRD Mamauju Regency.

Based on the results of the tests that have been carried out, the results obtained with a significant number of so that there is a positive and significant influence on the variables of emotional intelligence, intellectual intelligence, and spiritual intelligence on the performance of members of the DPRD Mamuju Regency simultaneously.

Based on the results of the research above, it can be interpreted that if emotional intelligence, intellectual intelligence, and spiritual intelligence work together, it will produce an influence on the performance of members of the DPRD Mamuju Regency. The performance of DPRD members has the power as a legislative body because DPRD members have the right of interpellation, the right of inquiry, and the right to express opinions. DPRD members also have the right to submit draft district/city regulations, ask questions, submit proposals and opinions, defend themselves, immunity rights, and protocol rights together will be able to ask for DPRD initiative rights and give birth to accountability which in the end can propose regional leaders to be dismissed.

CONCLUSION

The results of this study indicate that three X variables, namely emotional intelligence, intellectual intelligence, spiritual intelligence, have a positive and significant effect on the performance of members of the Regional Representatives Council of Mamuju Regency.
